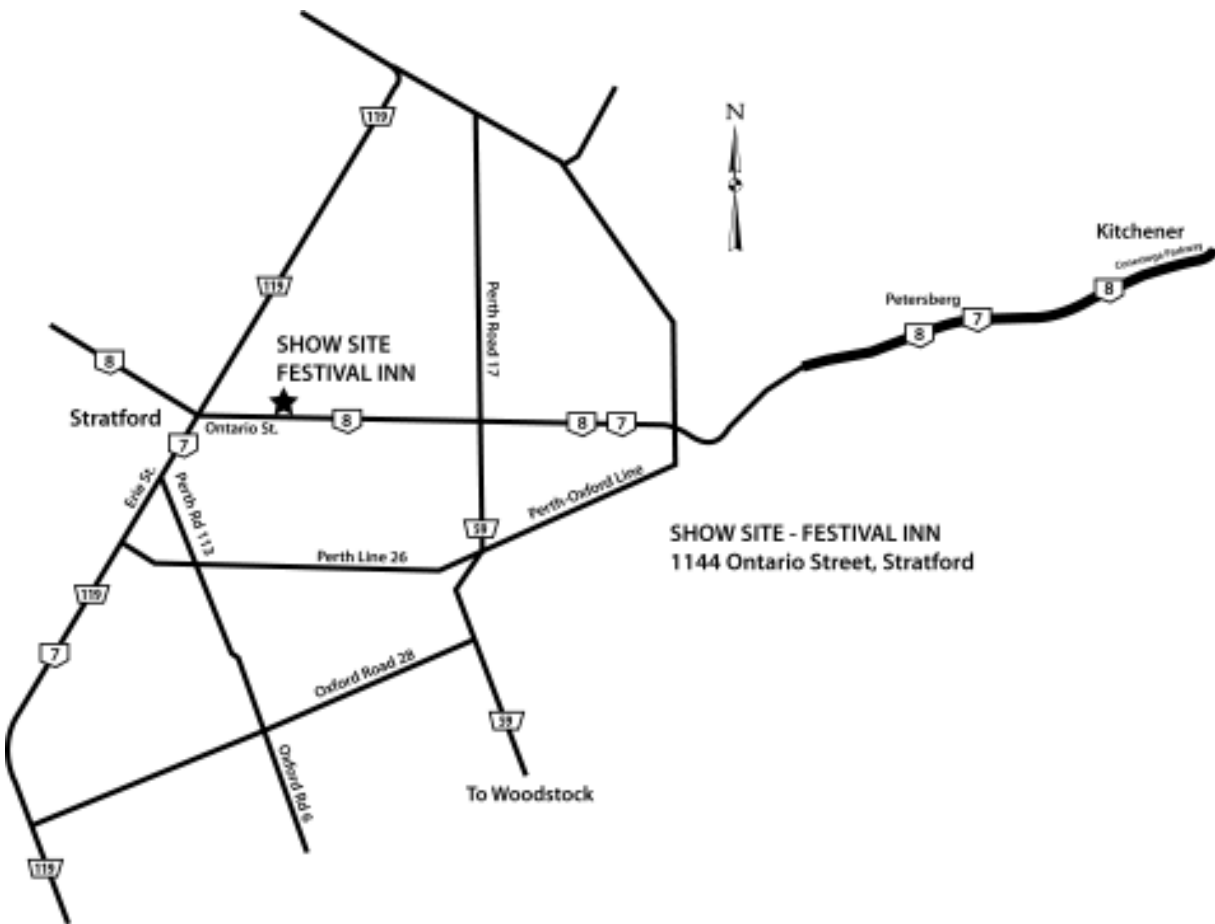

From the East (Toronto, Ottawa, Montreal):
